Secretary's Report: Jesse Lyons

The minutes from the January 2007 meeting were distributed and approved. (M/S, Jacquie Jacob/?).

Treasurer's Report: Lou Arrington

The treasurer's reported that we are surviving financially. During the year we had an income of \$320 for memberships (3 life and 4 student), \$30 for note card sales, and Bank Interest of \$160, and one CD of \$10,000 providing a balance of \$30,538.82.

Expenses reported were \$] 7, \$100.87 for the hospitality the past two years, \$259 for maintenance of the display materials and \$500 each year contributed in support of the 2006 and 2007 Nationa14-H Poultry and Egg Conference for a total of\$1397.92. We started the year with 4 CD amounting to \$35600, and now have 3 for just under \$27000 total. Also income of\$13.86 interest associated with the CD. Total assets of the Association were \$55,600 last year and now are \$57,500. This reflects an interest income of\$1896.78.

Milt Sunde will review the treasurer's books. Treasurer's report was accepted. (M/S, Jacob Jacob/Ralph Stonerock)

Lou Arrington reported that the book will be a coffee table type book, not a history per say. The book will be structured with contents arranged with:
