Instruction Sheet for 2022 Hall of Fame Selection

The American Poultry Historical Society recognizes leadership in the poultry industry by electing individuals of exceptional character and integrity, who have rendered outstanding and unselfish service to the industry to the Hall of Fame. Therefore, this is one of our industry's most prestigious recognitions. A maximum of five individuals are accepted for installation into the Hall of Fame every three years. The final selection is arrived at mathematically from rankings of an Evaluation Committee of 12 industry, educational, and regulatory leaders acting independently of each other. Successful nominees will be inducted during ceremonies at the International Poultry Exposition (IPPE) in Atlanta, GA.

#### **Nomination**

1. May be made by any person or organization.

2. Upon receiving the nomination forms, complete the "Nominator Information for Processing Nomination Forms and return it as soon as possible. This form is intended to help avoid duplicate nominations and provide necessary information, but does not obligate you to submit a nomination.

3. Nomination forms shall be completed and forwarded by E-mail (preferred) to: Dr. Michelle Hall, <u>mahall@clemson.edu</u> or by mail, to: Dr. Michelle Hall, 198 Melissa Drive, Walhalla, SC 29691.

4. The nomination form should be the <u>first</u> item in the materials submitted. Letters of support for the nomination should be attached to the nomination. If mailed, accompanying material (<u>restrictions as to length must be observed</u>) shall be securely stapled or attached. The sheets, including cover, should not exceed 9x12 inches.

5. The nomination shall be in the office of the committee chairman (see item 3) by September 1, 2021.

#### **Agreement to Provide Portrait**

The nominator agrees that if his/her nominee is selected, a high quality digital photo (3 or more M pixels) will be provided. This photo will be used for publicity purposes and to create a metal etched image of the nominee for placement in the American Poultry Industry Hall of Fame.

- 3. This is a confidential process and must be handled as such by all concerned.

- 5. The nominator will inform the successful nominee of their induction. This will be followed by an official letter from the American Poultry Historical Society.
